There should be no discussions about me between any member of the Church and friends or family of other members of the community as this could be considered defamation of character. I have discussed my situation with Kathy Worthington in Salt Lake City. I understand my rights. The Church's involvement should be strictly clerical. Should my requests continue to be disregarded and the harassment and ~~my~~ defamation of my character continue, I will be forced to seek legal redress.


Dear Sister





Dear Sister _____,

This is the written notice of the decision of the disciplinary council held on your behalf March 1, 2000. The decision of the council was that you be excommunicated from the Church for moral conduct unbecoming a member of the church. A person who is excommunicated is no longer a member of the Church and cannot enjoy any membership privileges, including the payment of tithes and offerings. You may attend any public Church meetings, but may not participate by speaking, praying or partaking of the sacrament. You may appeal this decision if you feel we may have acted improperly or that you have been treated unfairly.

Your letter stated your desire to have no contact with the Church. When we visited, you said you did not want to alter your behavior at this time and would like your membership in the Church ended. It must be remembered that the individual has great worth to our Father in Heaven, but sometimes the things we do must be condemned. We pray that you will repent and once again enjoy the peace and happiness found in the Gospel of Jesus Christ. You are a child of God and can do much good in your life. When you are ready, contact your current Bishop and he will help you work out your repentance with the goal of being baptized again and receiving the gift of the Holy Ghost. We wish you what happiness this world can bring, knowing that true happiness comes from living the commandments of God.
